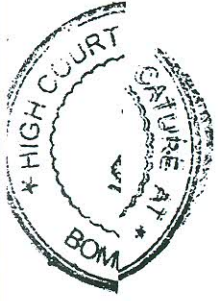

1. The issue is in connection with the demand notice issued to the Nursing Homes in connection with the change of users. Mr.Walawalkar pointed out that the order of the Municipal Commissioner dated 03-08-2011, wherein it has been stated that as per the earlier order of this Court dated 24-06-2011, the applications for renewal of the Nursing Home/Maternity Homes/Clinics shall be considered independently of the demand notice which is already issued. He further submits that licences have already been renewed and individual cases shall be considered on its own merits and if required, fresh demand notices will be issued.

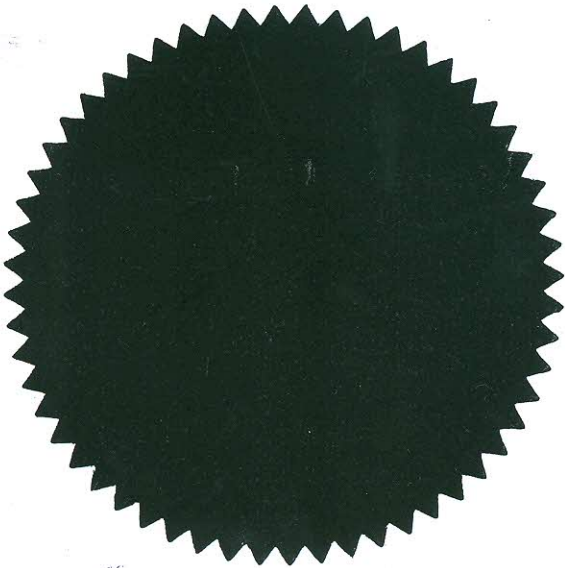
