We are concerned for our clients, i.e. the Petitioners in the captioned matter.

We are writing this in pursuance to our letter dated 24 June 2011. As you are aware, the Hon'ble High Court in the captioned Petition passed an order on 14 June 2011, directing therein that Applications for renewal of the registration of the petitioners' maternity and nursing homes shall be considered by the Corporation in accordance with law and if the petitioners are otherwise entitled for renewal, the registration shall be renewed independently of the Demand Notices/Circulars which are referred to in prayer clause (a) of the petition, i.e. the circulars dated 8 September 2009 and 8 October 2010 and the Circular dated 07.05.2011 issued by the Corporation.

Despite the order passed by the Hon'ble High Court, the concerned Health Officers are still not renewing the certificate of registration of our clients on the ground that they have no instruction from your office. We had thereafter issued a letter on 24 June 2011 to you thereby annexing the order of the Hon'ble High Court passed on 14 June 2011 for your doing the needful.

However, in spite of the letter dated 24 June 2011, it is shocking and surprising that the concerned AHO's are still not considering the renewal application of our clients on the ground that they have no instruction from your office. Our clients state that refusal to renew the certificate of registration despite an order being passed to that effect amounts to contempt of court and you are negligently and willfully disobeying the order of the Hon'ble High Court for reasons best known to you.

In view thereof, we have to request you to immediately instruct your concerned authorities and AHO's to take the application of our clients for renewal of registration of their nursing homes/maternity homes on record and consider the same with an immediate effect, failing which our clients shall be constrained to initiate appropriate proceedings including proceedings for contempt of court, solely at your costs and consequences.


